Responsibilities:

- The position has responsibility for Quarterly Pricing (Fiber, Fuels, Chemicals, Labor, some Supplies) used in Cost Modeling of Global Pulp and Paper Mills and Corrugated Sheet Plants
- Find sources of pricing data, and organize the collection of that data, and ensure consistent methodology (spot pricing, average pricing, list pricing, etc.). Oversee the retrieval and inputting of the source data
- Design, build and manage processes to fill in missing price information, and to ensure data quality
- Design, build and manage processes to apply regional pricing to individual Paper Mills, including adjustments stemming from a variety of sources (volume discounts, proximity to source and transportation options, etc.)
- Manage a logistics model that estimates the cost of transportation from Paper Mills to selected destinations. Pricing inputs, as well as Ports and 'Lane Management' are included
- Explain price variation quarter to quarter
- Work closely with backend team, and at the same time support consultants in explaining prices and market variations
- Perform analysis of data to identify opportunities to develop and improve existing tools
